AFFIDAVIT

STATE OF OKLAHOMA,
COUNTY OF WAGONER, SS:

THE UNDERSIGNED, OF LAWFUL AGE, BEING FIRST DULY
SWORN UPON OATH DEPOSES AND STATES:

In September of 2017 I, Stephanie Stephens District 27 Investigator for the Violence Against Women Act, was assigned a case. The case was one that was decades old and has been researched and worked by the Federal Bureau of Investigation (FBI). Once I was assigned the case I met with and interviewed Special Agent Adam Reynolds of the FBI. Special Agent Reynolds and I went through all the information that has been collected in regards to the case. After reviewing all the information and evidence collected I anticipate charges being filed against Henri Michele Piette. During my interview Special Agent Reynolds informed me of the following:

On August 15, 2016, [REDACTED], date of birth [REDACTED] 1984, was interviewed at the offices of the Kansas City Division of the FBI, 1300 Summit Street, Kansas City, Missouri 64105, regarding her being taken by her step-father Henri Michele Piette in 1997. [REDACTED] was interviewed by Child and Adolescent Forensic Interviewer (CAFI) Rachel Happel. [REDACTED] was informed as to the identity of the interview and the purpose of the interview. [REDACTED] provided the following information:

[REDACTED] stated in 1993 or 1994 Henri Piette, date of birth [REDACTED] 1954, lived near them in Springfield, Missouri when she lived at [REDACTED] in Springfield, Missouri. The first time she met him she was 10 years old. Piette had three children:

██████████, who was 13 or 14 years old; ██████████, who was four, or five years old and ██████████ who was three years old.

The first time Piette had sex with her was in Wagoner, Oklahoma. It is believed this happened in 1995 or 1996. It occurred in a house they were residing at in the back room ██████████ and ██████████ shared. The house was located at ██████████ Wagoner, Oklahoma. ██████████ believed she was either 11 or 12 years old when the sex occurred. ██████████ was on the bottom bunk and she bled after Piette got off of her.

While in Wagoner, Oklahoma ██████████ remembered when she was around 11 years old Piette took her to a van and married her. She added Piette gave her a ring and Piette's son, ██████████, officiated the marriage. The marriage occurred in Wagoner, Oklahoma.

██████████ said while the whole family was living in Wagoner, Oklahoma, Piette beat up her mother. ██████████ took ██████████ and her brothers to ██████████ Grandmothers house in Independence, Missouri. Piette traveled to Independence and retrieved ██████████ and the children and they went back to Oklahoma together. Upon returning to Oklahoma they purchased land and lived in a tent somewhere between Vian and Gore, Oklahoma. Piette then assaulted ██████████ again and she and the children went to a women's shelter in Poteau, Oklahoma. ██████████ stated while she was going to the school in Poteau her step-brother ██████████ came to get her from the school. She added her dad, Henri Piette, wanted ██████████ to get her. ██████████ said they went to a mobile home park and waited in a mobile home, near Tenkiller Lake. Piette left to pick up his children, ██████████. They then drove with someone else and stayed in a motel in Tulsa, Oklahoma. Piette told her if they were stopped to say she ran away with ██████████

It is believed that while living in Tulsa Piette changed their names. While in Tulsa they lived in a two story complex in Tulsa, Oklahoma, and Piette told ██████████ if they were caught, she would be in trouble. While living in Tulsa, Oklahoma Piette had problems with the law and had given ██████████ cocaine. ██████████ said Piette also had sex with her several times a day while they were in Tulsa.

After finding out that ██████████ was looking for them they moved to Oklahoma City, Oklahoma. ██████████ said she was 12 years old at that time and they lived upstairs in a rented apartment that looked like a big house. From Oklahoma City, Oklahoma they traveled to numerous locations throughout the United States and in Mexico. ██████████ stated they returned to Oklahoma a couple of times. Piette would drive to Oklahoma and have ██████████ mail letters just so people would believe ██████████ was still in Oklahoma. ██████████ stated she was sexually assaulted multiple times a day almost every day while she was with Piette.

In 2016, ██████████ was able to escape from Piette while in Mexico and made her way to the U.S. Embassy. The United States government was able to get ██████████ and

her children passports so they could enter the United States. Upon their arrival in the United States [REDACTED] began meeting with State and Federal Officials and providing statements on what had occurred. [REDACTED] has advised officials that Piette lived in Mexico and had strong connections with the Mexican Mafia.

Special Agent Reynolds was able obtain the following records related to [REDACTED]'s time in Wagoner, Oklahoma. Special Agent Reynolds located water records for the residence located at 115 N Moss Ave, Wagoner, Oklahoma under the name [REDACTED] with a starting date of 9/15/1995 through 6/24/1996. Special Agent Reynolds was also able to locate school records for [REDACTED] and [REDACTED] (Son of Henri Piette AKA [REDACTED]) that showed they attended school in Wagoner, Oklahoma in 1995 and 1996.

During an interview conducted by FBI Agents in Durango, Colorado on 1/30/2017, [REDACTED] stated that when he was about 15 years of age, he performed a marriage ceremony between his father, Henri Piette and his step sister, [REDACTED]. [REDACTED] was 11 years old at the time and they lived in Wagoner, Oklahoma. The wedding ceremony consisted of [REDACTED] asking if Piette and [REDACTED] took each other in marriage. He then said that Piette could "kiss the bride." Piette then gave [REDACTED] a kiss on the mouth.

During an interview conducted by a St. Bernard Parish Sheriff's Deputy Joseph Warren, [REDACTED] stated while in Wagoner, Oklahoma he saw Henri Piette put his hand down [REDACTED]'s pants while they were riding in a truck together. They were going from the house to a store. [REDACTED] stated Henri's hand was down [REDACTED]'s pants all the way to the store and all the way back. After getting back to the home [REDACTED] tried to tell people in the house what he saw and when Henri found out he smashed his head into a coffee table.

During an interview conducted by a St. Bernard Parish Sheriff's Deputy Joseph Warren, [REDACTED] stated she had witnessed Piette sexually assault [REDACTED] numerous times. The family was constantly traveling, not staying in anyone place for very long. Their travels included numerous states in the continental U.S. and in cities in Mexico. During these travels [REDACTED] and [REDACTED] would be sexually assaulted in the RV or bus that was being used as a home and as means of transportation. [REDACTED] stated [REDACTED] would get raped and beaten every day. [REDACTED] remembered witnessing [REDACTED] being raped in the house in Wagoner, Oklahoma. [REDACTED] also remembered that at night Henri would have [REDACTED] come to his bed and perform oral sex on him. [REDACTED] was approximately 4 to 5 years old at this time.

On September 7, 2017, Special Agent Reynolds was notified that Henri Piette had visited the U.S. Embassy in Mexico City attempting to obtain a U.S. Passport. It is believed that Piette has resided in Mexico and or Central America for a very long time and has deep ties to criminal organizations in Mexico, which can assist him in evading law enforcement. It is believed Piette has been staying in Mexico since [REDACTED]

██████ escaped. It is also believed he is trying to obtain a passport for the purpose of cashing United States Army Pension checks.

During the week of September 10th, Piette was contacting persons who aided ██████'s escape from Mexico and threatening these individuals. This Affiant has a good faith belief that Piette is attempting to contact ██████ and ██████ during the last week (September 10th).

WHEREFORE, AFFIANT PRAYS THIS HONORABLE COURT TO ISSUE A WARRANT FOR THE ARREST OF THE WITHIN NAMED DEFENDANT THAT HE MAY BE BROUGHT BEFORE A MAGISTRATE AND HELD TO ANSWER FOR THE OFFENSES OF:

Lewd Molestation of a Child- ██████ (Victim)
